

COOPERATION AGREEMENT

Based on the common ERASMUS+ project cooperation INTERBA

October 2023







IV. Decision-Making and Coordination

Decisions related to specific collaborations and projects shall be made jointly by the Parties. Coordination and communication among the Parties will be facilitated by designated contact persons from each organization.

V. Confidentiality:

The Partles agree to maintain the confidentiality of any proprietary or sensitive information shared during their collaboration.

VI. Duration and Termination

This agreement shall remain in effect for a period of 5 years, commencing on the date of signing, with the possibility of renewal by mutual written agreement between the parties. Either Party may terminate this agreement with written notice to the other Party at least 30 days prior to the intended termination date.

VII. Amendments

This agreement may be amended or modified in writing by mutual consent of the Parties.

VIII. Entire Agreement

This agreement constitutes the entire understanding between the Parties concerning future collaboration and supersedes all prior agreements and understandings between the Parties, whether written or oral. Both parties have agreed to cooperate in accordance with the relevant legislation of higher education of each of the parties.

IX. Applicable law and Jurisdiction

- a. This Agreement is governed by the Belgian law, being the neutral law from the partners part of this agreement.
- b. In case of any disputes on matters under this Agreement, which cannot be resolved by an amicable settlement, the matter shall have to be decided in accordance with the jurisdiction of Belgian law, at the Courts of Brussels.
- c. If any provision of this Agreement or the application of any such provision shall be considered invalid or unenforceable in whole or in part for legal requirements, all other stipulations remain valid and binding to both parties.
- d. If any provision in this Agreement should be wholly or partly ineffective, the parties to this Agreement undertake to replace the ineffective provision by an effective provision which comes as close as possible to the purpose of the ineffective provision.
- e. This Agreement is concluded in English. In the event of translation of this Agreement and its annexes, the English version shall prevail.
